RESPONSIBLE DECLARATION AND INFORMED CONSENT FOR THE PARTICIPATION IN THE 2020/2021 MUNICIPAL SPORTS SCHOOLS (MSS), ORGANIZED BY THE SPORTS COUNCIL OF THE HONORABLE CITY COUNCIL OF ORIHUELA

as father / mother / guardian of _____ (participant), in relation to his/her participation in the Municipal Sports Schools (MSS) of the Department of Sports of the Orihuela City Council, I RESPONSIBLY DECLARE:

1st.- Our son / daughter hasn't had symptoms related to COVID-19 disease during the last 14 days, nor has he / she been in close contact with a probable or confirmed case of COVID-19.

2nd. – Our son/daughter (choose an option):

- Doesn't belong to any of the risk groups that are most vulnerable to infections against COVID-19.
- Belongs to vulnerable risk groups due to COVID-19 infections, but we have a medical authorization to participate in activities such as Sports Schools, which we attach at this time.

3rd.- Our son/daughter (choose an option):

- Doesn't live with people with special vulnerability to COVID-19.
- Lives with people with special vulnerability to COVID-19, but we have the authorization of the partners to participate in the Municipal Sports Schools.

4th.- We're committed to making a daily review of the state of health by taking temperature and continuous monitoring of the symptoms of COVID-19.

5th.- I know the conditions of participation in the Municipal Sports Schools and the protocol for the adaptation of organizational measures, operation and execution of activities in MSS, for prevention of infections against COVID-19.

6th.- We undertake to accept the protocols promoted by Municipal Sports Schools, as well as the preventions and hygiene measures proposed and consistent with those described at time by the Health Authority.

7th.- I know and have been informed about the risks of the activity: sports practice entails risks for health and personal integrity, such as injuries, cardiorespiratory alterations and

aggravation of pathologies as a result of exertion and the triggering of accidents, blows, falls, etc. I undertake to inform the technical staff about contraindications, illnesses or optically recognized alterations in the state of health of our son/daughter. In addition, in the current pandemic situation I'm aware that by the fact of participating in the Municipal Sports Schools of the Sports Department of the Orihuela City Council is a risk of contagion by SARSCoV2 for our son/daughter. I'm aware that, for this reason it may be vulnerable to the development of COVID-19 disease.
