GENERAL ENROLLMENT CONDITIONS FOR MUNICIPAL SPORTS

SCHOOLS SEASON 2020/2021

Through the following conditions, it's reported by the Sports Department of the Orihuela City Council, about the aspects and rules that enrollment in any of the modalities offered in the MSS for this season entails. Acceptance of these conditions is essential to make the registration effective. Any student who hasn't accepted the Enrollment Conditions will not be considered enrolled.

1. Economic conditions. Payment methods. Bonuses

- a) People interested in any of the sports modalities offered must pay the Enrollment Fee and the Quarterly Fees (Direct Debt), stipulated for this purpose in the Regulatory Tax Ordinance in force.
- b) The prices established in the Regulatory Tax Ordinance in force are the following:

As a novelty this season, and due to the extraordinary health situation, the payment of the fee corresponding to enrollment will not be made at the moment of the inscription. Once the start of activities is confirmed with normality, and these have the minimum necessary registration, the Department of Sports, will proceed to inform the registrants

about the procedure to follow and deadlines for the payment of said fee.

The payment will be the confirmation of the registration in the chosen modality. Once the enrollment fee has been paid, they'll be considered enrolled in the MSS Program. Due to the special situation generated by COVID-19, during the enrollment procedure, the father/mother/guardian must complete and sign the **INFORMED CONSENT DOCUMENT AND RESPONSIBLE DECLARATION** that you will find on the website and attach it in your personal space, at the My Documents tab.

Fees will be paid by direct debit, which will be sent quarterly. The charge for these receipts will be made to the account number provided at the time of registration and you'll be notified about 5 days in advance, by email.

- a) In case of non-payment that causes the return of any of the quotas of the previous season, it will not be possible to register. The interested party should contact the Department of Sports where they'll be informed of the steps to follow to solve the payment incident.
- b) If the situation of non-payment and refund of fees is repeated, the athlete will be **IMMEDIATELY UNREGISTERED** and the impossibility of making use of any activity offered by this Department, until the pending payments are made.
- c) Regarding the return of any of the fees, enrollment and fees, and in compliance with the Applicable Legal Regulations, it will be requested by the means indicated by the Administration. Those rates that haven't been able to enjoy will be subject to refund. A refund of the registration fee may be requested in case the activity hasn't started or hasn't attended any of the sessions. Regarding the request for refund of fees, it'll be made before the beginning of the quarter that isn't going to be enjoyed, indicating the reason.
- d) Registered users, who are members of the same family unit, will be entitled to the discounts established in the Regulatory Tax Ordinance in force.

Thus:

- a. H.1: When there are 2 members of the same family unit registered, a 50% discount will be applied to the member whose fee has the lowest amount.
 - b. H.2: From the 3rd member and later, they will only pay the enrollment fee. They will be exempt from paying quarterly fees.
 - c. H.3: These discounts/bonuses will not apply to sports for adults.
- e) You may request financial aid to defray part of the expenses of this sports program. **The Department of Sports will approve, during the months of January and February 2021, some Regulatory Bases for the Granting of Scholarships of the “SPORT FOR ALL” program, on the promotion of sports practice in MSS.** The information on these Scholarships will be published in the Official Gazette of the Province of Alicante, on BDNS, on the municipal website (in the Sports area), and on the Orihuela City Council notice board. **The granting of this aid applies to quarterly installments. The registration fee is mandatory and doesn't have any help.**

2. GENERAL ASPECTS, INFORMATION AND RULES

2.A. The starting ages in each sport are those indicated below:

2.B. Depending on the category, or sport modality, two or three training sessions a week will be provided, always following the sports program designed by qualified technicians designated for this purpose.

2.C. The training sessions may be held at any of the municipal sports facilities, as well as in others with which there are use agreements. The competition days will take place in the facilities (local or not) designated by the

different organizing entities (Federations, Associations, etc.).

2.D. The Technical Directorate of this Sports Program will be in charge of assigning a training/competition group according to the technical criteria that are considered appropriate. Enrollment in this Program doesn't guarantee the status of any sports level (federated, non-federated, etc.), and the student will be assigned to the group / team that, after technical evaluation, best suits their qualities.

2.E. Those enrolled in this Sports Program will be covered by a **Sports Accident Insurance** (only coverage will be given to accidents that occurred, and accredited, by the practice of this specific sports activity), either through the Sports Federation corresponding, or by the policies subscribed for this purpose by the City Council.

2.F. **Due to the special situation in which we find ourselves due to COVID-19 and in order to reduce contacts and minimize the risk of contagion, during the 2020/21 season there will be no bus service, neither for training sessions, nor for competition.**

2.G. The Department of Sports will provide the member with the **necessary sports equipment and for collective use** (never material for individual use; rackets, boots, gloves, etc.) necessary for the performance of the chosen sports practice, as well as an **Equipment Training** (except in adult modalities) for use during the activity. Said to sportswear, it will be **mandatory for training and competition matches. At the time of enrollment, a questionnaire will have to be completed with the desired size. In case of not providing such information, the Department of Sports doesn't guarantee the delivery of the same and isn't responsible for the comparative injury that may arise with the rest of the athletes or members of the team.**

2.H. This sports program will have Suggestion/complaint sheets.

2.I. Documentation (Registration, Application, etc.) submitted after the deadline

established in each case will not be accepted.

2.J. All those registered in the MSS must inform the Department of Sports and in particular the monitor, if during the 2020-2021 season, there is any alteration/modification in their eating habits (for cultural, religious, health, aesthetic reasons, etc.). In this way, the monitor will be able to adapt the training sessions and matches, to the needs and optimal conditions of each student.

3. ENROLLMENT DEADLINES

3.A Due to the current complex situation, the Department of Sports of Orihuela City Council has implemented measures, recommendations and obligations for use the MSF and organization of activities and events carried out in the same during the 2020/21 season to ensure the health and safety for our users in this program. Among them, the renewal and new enrollment procedure in MSS will be carried out within the established deadlines and through the online processing procedure.

The terms will be:

- **Renewal: from September 3rd to 7th in Orihuela. From September 21th to 28th in Orihuela Beaches.**
- **New Enrollment: from September 8th in Orihuela. From September 28th in Orihuela Beaches.**

3.B In the modalities for adults this term will not be given, because the registration will not be renewed. Those users must complete the procedure in September, complying with the provisions for newly enrolled students.

3.C The **registration period** will remain open, **throughout the season**, for those sports modalities that have **available places**. In the case of adult sports, a minimum number of registrants will be required to carry out the activity.

4. CANCELLATIONS

4.A Temporary or permanent voluntary unsubscriptions of students must be requested by filling in the corresponding form from the website. After this procedure, the Administration will verify, by email, the confirmation of the request. Payments corresponding to services not enjoyed will be canceled. Students who aren't up to date with payments at the time of application will not be unsubscribed and they'll have to pay the debt for the unsubscription to take effect. Failure to attend sports sessions, without having properly requested and through the established channels for unsubscription, will not entail any right for future claims.

4.B The Department of Sports may unsubscribe a student in case of inappropriate behavior or relevant incidents, aspects that will have been communicated by the monitor or director of the school and evaluated by the Organization's technicians.

4.C The Sports Department can unsubscribe a student if he isn't up to date with the payment of quarterly fees and is a repeat action.

4. D the granting of unsubscription, voluntary or not, will entail the loss of rights acquired as a user of this activity, as well as the rights acquired as a student of the MSS.

DATA PROTECTION

Due to the inclusion of new technologies within the didactic means available to the sports community of our municipality and given the possibility that images of the students of the MSS may appear during sports activities, since the right to one's own image is recognized in article 18 of the Constitution and regulated by Law 1/1982 of May 5th, on the right to honor, personal and family privacy and one's own image, and Organic Law 3/2018, of December 5th, Protection of Personal Data and guarantee of digital rights. With the acceptance of the enrollment conditions, the parents/guardians give their consent to be able to make, and publish, if necessary, audiovisual content in which they appear and only with sports character. (Students of the MSS in its

EXCEPTIONAL COVID-19 MEASURES

Faced with this exceptional health situation due to COVID-19, the Department of Sports of the City Council of Orihuela has carried out several measures, recommendations and obligations for the use of MSF and the organization of activities or events held there during the 2020/21 season. Among them and in relation to the renewal and enrollment in the MSS are the following:

- The use of the mask will be mandatory for all students over 6 years, while they're in common areas of the sports facilities, and voluntary at the time of sports practice.
- Hand disinfection will be mandatory. Points with hydroalcoholic gels will be set up in all sports facilities; although it's recommended that each user carry theirs.
- Students will have to use their water bottle for **INDIVIDUAL USE ONLY**.
- Circuits have been established for the entry, exit and collection of athletes in all sports facilities. Students and their companions must respect them to ensure everyone's safety.

By accepting these Enrollment Conditions, it's stated that they have been read and understood all of that. In addition, the rights and duties of the athlete, parents/guardians and organization are confirmed. When registering in the MSS, it's understood that the established norms are accepted, as well as the new indications regarding protocols, procedures and health and safety measures due to COVID-19.
